2	Applicants are advised to ensure, before appearing for the Selection Process, that they possess the minimum essential qualification and experience laid down for the post. Qualification obtained has to be from a recognized University/Institute. Eligibility in terms of age, qualification, and experience of a candidate shall be considered as on the date of the Selection Process.
3	The number of vacancies indicated in the notification is tentative. IIIT Dharwad reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIIT Dharwad reserves the right to NOT fill any of the posts advertised.
4	No TA/DA will be paid for attending the Selection Process.
5	In case of any inadvertent mistake in the process of selection, which may be detected at any stage, even after issue of the appointment letter, the Institute reserves the right to modify, withdraw, or cancel any communication made to the Applicants.
6	After joining the service of the Institute, the person(s) will have to abide by the Rules, Regulations, Ordinances, Statutes, and Acts of the Institute applicable from time to time. She/he may be assigned any duty within or outside the Institute, depending upon the exigency of the work.
7	The Institute shall verify the antecedents or documents submitted by a person at the time of appointment or during the tenure of the service.
