2. Applicants are advised to ensure, before appearing for the Selection Process, that they possess the minimum essential qualification and experience laid down for the post. 3. The number of vacancies indicated in the notification is tentative. IIIT Dharwad reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIIT Dharwad reserves the right to NOT fill any of the posts advertised.
4. No TA/DA will be paid for attending the Selection Process.
5. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to modify, withdraw or cancel any communication made to the Applicants.
