Sl. No.	Queries Raised by Bidders	Clarifications / Answers Provided
1	Can one bidders participate in both tenders?	Bidders may participate in both <i>Mess 1</i> and <i>Mess 2</i> tenders separately. However, the contracts for <i>Mess 1</i> and <i>Mess 2</i> will be awarded to different agencies and not to the same bidder.
2	Is there any limit on fruits, bananas, and eggs?	Fruits- 50 grams and bananas – 2nos will be provided in limited quantity; no limit on eggs.
3	What are the serving locations?	Mess1- Boys Hostel, Mess2- Girls Hostel and outside hostels as per requirement.
4	Is ₹140 fixed?	Yes, the rate of ₹140 per day per student is fixed (Inclusive of GST).
5	Who will provide utensils and handle maintenance?	Utensils will be provided by IIIT Dharwad. However, the daily cleaning, maintenance, and proper upkeep of the utensils shall be the responsibility of the contractor.
6	Who will provide service to outside hostels and how many?	The Mess2-contractor will provide service to outside hostels; the number of hostels will be informed at the time of commencement and the distance to the hostels from the campus is max 10 KM
7	What is the bid validity period?	The bid validity period will be 180 days from the date of opening.
8	What is the initial contract duration?	The contract shall be awarded initially for (12 Months) 1 year. It may be further extended subject to the satisfactory performance for a period of 1 + 1 year [Total 3 years including awarded year]
9	How will vacation periods be handled?	Services may be required during the 3-month vacation period unless otherwise informed. [The Caterer shall continue to provide meals as per the regular approved menu at the same agreed cost, the numbers may range between 20 -50 students.]
